**RESOLUTION NO. 2025 1 14**

**WHEREAS,** the regular election for City Council of the City of Annetta South, as set forth by the Texas Election Code, is required to be held on May 3, 2025, at which time the voters will elect a Mayor and City Council Places 3 and 5;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANNETTA SOUTH, TEXAS:**

Section 1: THAT an election is hereby called to elect a Mayor and City Council Places 3, and 5, to serve until May of 2027, or until their successors are duly elected and qualified. Such election shall be held at New Faith Baptist Church 3303 W FM 5 Aledo, TX 76008. on the 3rd day of May, 2025, from 7:00 a.m. until 7:00 p.m.

Section 2: Qualified persons may file as candidates by filing applications in the office of the City Secretary, by appointment at New Faith Baptist Church 3303 W FM 5 Aledo, TX 76008. between the hours of 7:30 a.m. and 4:30 p.m., Monday through Friday, beginning January 15, 2025, and ending at 4:30 p.m. February 14, 2025.

Section 3: Early voting shall commence on April 22, 2025 and will continue through April 29, 2025 and shall continue Monday through Friday from 8:00 a.m. until 5:00 p.m.

Section 4: The election shall be a joint election with those entities such as Annetta South, Aledo Independent School which choose to have a joint election with the City and shall be conducted by Parker County, which shall designate Election Judges, clerks and Early Voting Clerks., and provide voting machines. To the extent required by law, those persons designated by Parker County as election officers and clerks are hereby appointed by the City. The Mayor is hereby authorized to execute a contract with Parker County on behalf of the city for the cost of the election.

Section 5: The election shall be conducted according to the election laws of the State of Texas.
