

AND J&B DISPOSAL SERVICE AGREE TO AMEND ORDINANCE NO. 028 PASSED BY THE TOWN OF ANNETTA SOUTH, TEXAS, APRIL 9, 1987, BY REVISING SECTIONS IV, (6), AND V OF SAID ORDINANCE.

WHEREAS, the TOWN OF ANNETTA SOUTH, Texas, hereinafter referred to as "TOWN", and J&B DISPOSAL SERVICE, hereinafter referred to as "J&B DS" have agreed to renew contract for service commencing April 1, 1990; and

WHEREAS, the TOWN requests J&B DS to provide four (4) thirty (30) yard open top containers free of charge, if needed, by supplying two (2) containers for a spring cleanup and two (2) containers for a fall cleanup, if needed, on dates set up by the TOWN; and

WHEREAS, the J&B DS requests an increase in the monthly charge from residential customers due to increase in the cost per ton for landfill dumping fees,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF ANNETTA SOUTH, TEXAS, THAT:

SECTION I - The provision of Section IV(6), Duties of J&B DS shall be revised in part to read as follows:

J&B DS shall provide a total of four (4) thirty (30) yard open top containers, if needed, by furnishing two (2) containers for a one-day cleanup in the spring and two (2) containers for a one-day cleanup in the fall of the year on the dates scheduled by the TOWN. There will be no charge assessed to the TOWN by J&B DS for these containers.

SECTION II - The provisions of Section V, Rates, shall be revised in part as follows:

The monthly charge to the residential customer for service shall be \$8.50. J&B DS will retain a monthly net rate of \$8.00 per residential customer and pay the TOWN \$0.50 per residential customer.

SECTION III - This agreement shall become effective April 1, 1990, and remain in force for three (3) years, renewable each year, unless J&B DS or the TOWN notify the other party forty-five (45) days, prior, in writing.

SECTION IV - Other than the language set forth in Sections I, II, and III of this ordinance, all of the terms of the original agreement between J&B DS and the TOWN OF ANNETTA SOUTH, Texas, entered into on the 9th day of April, 1987, attached hereto as Exhibit A and incorporated herein for all purposes remain in full force and effect as originally agreed to by the parties.
