AN ORDINANCE INCREASING THE MAXIMUM PENALTIES FOR VIOLATING CERTAIN TOWN OF ANNETTA SOUTH ORDINANCES INCLUDING ORDINANCE 008, THE ZONING ORDINANCE; ORDINANCE 011 , THE SUBDIVISION ORDINANCE; ORDINANCE 014, THE TOWN OF ANNETTA SOUTH PLUMBERS AND ELECTRICIANS ORDINANCE; ORDINANCE 023 REGULATING PARKING ON PUBLIC STREETS, AND ORDINANCE 030 ESTABLISHING TRUCK ROUTES AND LIMITING TRUCK WEIGHTS ON CERTAIN STREET, AND PROVIDING FOR PUBLICATION.

WHEREAS, Section 54.001, Tex. LOC. GOV'T CODE, provides general enforcement authority and for fines for violation of a municipal rule, ordinance or police regulation; and

WHEREAS, the Board of Alderman desires to increase the maximum penalties for violating city ordinances consistent with such provision; NOW, THEREFORE,

BEIT ORDAINED BY THE BOARD OF ALDERMAN OF THE TOWN OF ANNETTA SOUTH, TEXAS:

Section 1: THAT Section 23 of Ordinance No. 008 is hereby amended to read as follows:

## "SECTION 23 - VIOLATION AND PENALTIES

Any person, firm or corporation who violates any provision of this ordinances shall be deemed guilty of a misdemeanor and upon conviction, fined in an amount not to exceed $\$ 2000.00$. Each day that violation exists shall constitute a separate offense punishable hereunder."

Section 2: THAT Article XI of Ordinance No. 011 be amended to read as follows:

> "ARTICLE XI
> PENAL PROVISIONS

Any person, firm or corporation who violates any provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction, fined in an amount not to exceed $\$ 500.00$. Each day that a violation exists shall constitute a separate offense punishable hereunder."

Section 3: THAT Section X of Ordinance No. 014 be amended to read as follows:

> "SECTION X PENAL PROVISION

Any person, firm or corporation who violates any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction, fined in an amount not to exceed $\$ 500.00$. Each day that a violation exists shall constitute a separate offense punishable hereunder."

Section 4: THAT Section VIII of Ordinance No. 023 be amended to read as follows:

> "SECTION VIII PENAL PROVISIONS

Any person, firm or corporation who violates any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction, fined in an amount not to exceed $\$ 500.00$. Each day that a violation exists shall constitute a separate offense punishable hereunder."

Section 5: THAT Section V of Ordinance No. 003 be amended to read as follows:

## "SECTION V <br> PENAL PROVISIONS

Any person, firm or corporation who violates any provision of this ordinance shall be deemed guilty of a misdemeanor and upon conviction, fined in an amount not to exceed $\$ 500.00$. Each day that a violation exists shall constitute a separate offense punishable hereunder."

Section 6: The City Secretary is hereby authorized and directed to cause this ordinance to be
published in its entirety in the official newspaper of the city once if a weekly paper, or in every issue for two days if a daily paper.

Section 7: This ordinance takes effect when published.
