ORDINANCE NO. 57

**AN ORDINANCE CANCELLING THE MAY 13, 2006, REGULAR
ELECTION OF THE TOWN OF ANNETTA SOUTH, TEXAS, AND
DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO
OFFICE; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Town of Annetta South, Texas is a Type A general-law municipality located in Parker County, operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, in accordance with law a general election has been ordered for May 13, 2006 for the purpose of electing a Mayor and City Council Places 3 and 5 to serve on the city council of the Town of Annetta South; and

WHEREAS, no proposition is to appear on the ballot in that election; and

WHEREAS, the city secretary has certified in writing that each candidate on the ballot is unopposed for election to office; and

WHEREAS, the filing deadlines for placement on the ballot and declaration of write-in candidacy have passed; and

WHEREAS, in these circumstances Subchapter C of Chapter 2 of the Election Code authorizes a governing body to declare each unopposed candidate elected to office and cancel the election; **NOW, THEREFORE,**

BE IT ORDAINED BY THE CITY COUNCIL, THE TOWN OF ANNETTA SOUTH, TEXAS.

Section 1. THAT the following candidates, who are unopposed in the May 13, 2006, general election, are hereby declared elected to office, and shall be issued a certificate of election:

MAYOR: Gerhard Kleinschmidt

CITY COUNCIL PLACE 3: Danny Boutwell

CITY COUNCIL PLACE 5: William Gordon

Section 2: The city secretary is directed to post a copy of this ordinance at each designated polling place on May 13, 2006.


Section 3: This ordinance shall be in full force and effect immediately upon passage.


