

**CITY OF ANNETTA SOUTH
ORDINANCE NO. 2018-12-11**

**AN ORDINANCE ADOPTING THE CITY OF ANNETTA SOUTH
BUDGET FOR THE FISCAL YEAR JANUARY 1, 2019, THROUGH
DECEMBER 31, 2019.**

WHEREAS, in accordance with Section 102.001, et. seq., Texas Local Government Code, the Mayor, at least 15 days prior to the public hearing thereon, submitted to the City Council a budget for 2018 and the Council determined that a public hearing should be held at a time and place which was set forth in a notice published at least seven (7) days prior to said hearing; and

WHEREAS, such public hearing on the budget was duly held and all interested persons given an opportunity to be heard for or against any item therein;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANNETTA SOUTH, TEXAS:

Section 1: THAT the City Council of the Annetta South, Texas, for the fiscal period beginning January 1, 2019, and ending December 31, 2019, in words and figures as shown therein, are adopted and approved as filed herewith.

Section 2: THAT the Mayor be and is hereby authorized to make inter-department and inter-fund transfers during the fiscal year as deemed necessary in order to avoid over-expenditure of particular accounts.

Section 3: THAT the Mayor or his designee be and is hereby authorized to invest any funds not needed for current use in any lawful manner. Interest accrued from investments shall be deposited to the interest income account of the funds from which the principal was invested.
