**RESOLUTION NO. 2024-1-9**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANNETTA SOUTH CALLING A GENERAL ELECTION TO ELECT CITY COUNCIL PLACES 1, 2 AND 4; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the regular election for City Council of the City of Annetta South, as set forth by the Texas Election Code, is required to be held on May 4, 2023, at which time the voters will elect City Council Places 1, 2 and 4;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANNETTA SOUTH, TEXAS:**

Section 1: THAT an election is hereby called to elect City Council Places 1, 2 and 4, to serve until May of 2026, or until their successors are duly elected and qualified. Such election shall be held by Parker County Elections at the designated voting sights on the 4<sup>th</sup> day of May, 2024, from 7:00 a.m. until 7:00 p.m.

Section 2: Qualified persons may file as candidates by filing applications with the office of the City Secretary, by appointment at New Faith Baptist Church 3303 W FM 5 Aledo, TX 76008. between the hours of 7:30 a.m. and 4:30 p.m., Monday through Friday, beginning January 17, 2024, and ending at 4:30 p.m. February 16, 2024.

Section 3: Early voting shall commence on April 22, 2024 and will continue through April 30, 2024 and be run by the Parker County Elections Administrator by a contract made between the City of Annetta South and Parker County.

6 Section 4: The election shall be a joint election with those entities such as The town of  
8 Annetta, Aledo Independent School which choose to have a joint election  
10 with the City and shall be conducted by Parker County, which shall  
12 designate Election Judges, clerks and Early Voting Clerks, and provide  
14 voting machines. To the extent required by law, those persons designated  
by Parker County as election officers and clerks are hereby appointed by  
Parker County. The Mayor is hereby authorized to execute a contract with  
Parker County on behalf of the City of Annetta South to run and for the cost  
of the election.

16 Section 5: The election shall be conducted according to the election laws of the State  
of Texas.
